

## CONTEST TERMS & CONDITIONS

SEE BELOW FOR FULL CONTEST DETAILS. PARTICIPATION IN THIS CONTEST CONSTITUTES YOUR FULL AND UNCONDITIONAL ACCEPTANCE OF, AND AGREEMENT TO BE LEGALLY BOUND BY, THESE CONTEST RULES (THE “CONTEST RULES”).

### CONTEST PERIOD.

1. Coinsquare’s holiday giveaway season (“Cryptomas”) begins on Monday December 6th, 2021 at 10:00 a.m. Eastern Time (“ET”) and ends on Tuesday December 18th, 2021 at 10:00 a.m. ET (the “Cryptomas Period”). Within the Cryptomas Period there are twelve (12) separate Cryptomas Contests, each with a Contest Period as follows:
  - a. **Day 1** - Begins December 6, 2021 at 10:00 a.m. ET; ends December 7, 2021 at 10:00 a.m. ET
  - b. **Day 2** - Begins December 7, 2021 at 10:00 a.m. ET; ends December 8, 2021 at 10:00 a.m. ET
  - c. **Day 3** - Begins December 8, 2021 at 10:00 a.m. ET; ends December 9, 2021 at 10:00 a.m. ET
  - d. **Day 4** - Begins December 9, 2021 at 10:00 a.m. ET; ends December 10, 2021 at 10:00 a.m. ET
  - e. **Day 5** - Begins December 10, 2021 at 10:00 a.m. ET; ends December 11, 2021 at 10:00 a.m. ET
  - f. **Day 6** - Begins December 11, 2021 at 10:00 a.m. ET; ends December 12, 2021 at 10:00 a.m. ET
  - g. **Day 7** - Begins December 12, 2021 at 10:00 a.m. ET; ends December 13, 2021 at 10:00 a.m. ET
  - h. **Day 8** - Begins December 13, 2021 at 10:00 a.m. ET; ends December 14, 2021 at 10:00 a.m. ET
  - i. **Day 9** - Begins December 14, 2021 at 10:00 a.m. ET; ends December 15, 2021 at 10:00 a.m. ET
  - j. **Day 10** - Begins December 15, 2021 at 10:00 a.m. ET; ends December 16, 2021 at 10:00 a.m. ET
  - k. **Day 11** - Begins December 16, 2021 at 10:00 a.m. ET; ends December 17, 2021 at 10:00 a.m. ET
  - l. **Day 12** - Begins December 17, 2021 at 10:00 a.m. ET; ends December 18, 2021 at 10:00 a.m. ET
2. By participating in any of the Cryptomas Contests, each entrant agrees to abide by and be bound by these Contest Rules. Entrants further agree to abide by and be bound by all decisions of Coinsquare Ltd. (the “Sponsor”), which shall be final and binding, without

right of appeal, in all matters relating to any of the Cryptomas Contests and the awarding of the prizes, including without limitation eligibility and/or disqualification of entries.

### **ELIGIBILITY.**

3. Participation in any of the Cryptomas Contests is open to all residents of Canada (excluding Quebec) who have reached the age of majority in their province or territory of residence at the time of entry. Excluded from eligibility are the officers, directors, employees, agents and representatives (and those with whom such officers, directors, employees, agents and representatives are domiciled) of the Sponsor or any of the Sponsor's subsidiaries and affiliates.

### **HOW TO ENTER.**

4. **NO PURCHASE NECESSARY.** To participate in each Cryptomas Contest you must:
  - a. Have a valid Coinsquare account (an "Account"). If you do not have an Account, visit the App store and register in accordance with the enrollment instructions; and
  - b. During the Contest Period of the Cryptomas Contest you wish to enter, interact (i.e. comment, follow, like etc.) with Coinsquare via [Twitter](#) and/or, [Facebook](#) and/or, [Instagram](#) (collectively, the "Coinsquare Socials") in accordance with the instructions posted on each of the Coinsquare Socials at the start of that Contest Period.
5. You may enter each Cryptomas Contest as many times as you like within its Contest Period. Entrants will receive one (1) Entry in the relevant Cryptomas Contest for each eligible comment/interaction in accordance with these Rules, regardless of the social platform used to enter. For greater certainty and the avoidance of doubt, there is no limit on the amount of times you can enter each Cryptomas Contest within the Contest Period.
6. For greater certainty and avoidance of any doubt, entries are only collected and valid if they occurred within the relevant Contest Period for each Cryptomas Contest.

### **DRAW & WINNER SELECTION.**

7. At the close of each Cryptomas Contest, a random draw will be conducted from among all eligible entries received during the relevant Cryptomas Contest Period for the purpose of selecting a Prize winner. Odds of being selected depend on the number of eligible entries received during the relevant Contest Period for and the amount of times you entered.

8. Being selected as a winner for any of the Cryptomas Contests does not affect your chances of being selected as a winner for the remaining days of Cryptomas.

#### **PRIZE.**

9. There will be one (1) prize to be won for each Cryptomas Contest for a total of twelve (12) prizes available throughout the Cryptomas Period (each, a "Prize"). The Prize available to be won for each Cryptomas Contest will be displayed on the Coinsquare Socials at the start of the relevant Cryptomas Contest Period.
10. Prizes that contain cryptocurrency shall be funded to the selected winner's Account at the market price at the time of funding.
11. All Prizes must be accepted as awarded and are not transferable. No substitutions except at Sponsor's option. Sponsor reserves the right to substitute the prize or a prize component with one of equal or greater value, including without limitation, but solely in the Sponsor's discretion, a cash award. Prizes will only be awarded to the person who is the owner of the Account.

#### **PRIZE CLAIM CONDITIONS.**

12. In order to be declared a winner, the selected entrant's online presence must pass a content audit conducted by the Sponsor. The Sponsor reserves the right to disqualify selected entrants who display an online presence that does not align with the Sponsor's content policy, which includes without limitation, all content that: uses profanity, displays hateful or discriminatory language, promotes illegal, dangerous or violent harmful practices or behaviour or is harmful or offensive in nature.
13. All selected winners that pass the content audit will be contacted via the social media platform with which they have entered and won and notified via the social media platform with which they have entered and won and notified. WINNER NOTIFICATIONS WILL ONLY BE SENT FROM THE OFFICIAL COINSQUARE SOCIAL PLATFORM ACCOUNTS. The selected entrant must: (i) respond to notification of selection within two (2) weeks of first attempt by Sponsor; (ii) correctly answer, unassisted, a time-limited mathematical skill-testing question by email.
14. By accepting the Prize within two (2) weeks of it being sent by Sponsor, you confirm your compliance with the Contest Rules, and agree to release the Sponsor from any liability in connection with this Contest or the use, misuse, awarding or possession of any prize; and, agree to otherwise comply with these Contest Rules.
15. Return of the Prize, or any part thereof, or winner notification as undeliverable, inability to reach selected entrant or failure of selected entrant to respond to notification within

two (2) weeks of first attempt by Sponsor or Sponsor's agent, failure to provide proof of eligibility (if requested), release documents, or other required documentation in a timely manner, failure to correctly answer the skill-testing question, or other non-compliance with these Contest Rules may result in disqualification, forfeiture of the Prize, or part thereof, and, at Sponsor's sole discretion, selection of an alternate eligible entrant for the forfeited Prize, or part thereof, in accordance with these Contest Rules, who will be subject to disqualification in the same manner.

Without limiting the foregoing, the Sponsor, any of Sponsor's suppliers or contractors shall not be responsible for: (a) any incomplete or inaccurate information that is caused by programming associated with or utilized in the Contest, or by any technical or human error which may occur in the processing of submissions in the Contest; (b) lost, interrupted, or unavailable network, server, service provider, on-line systems, telephone networks or telephone lines, or any other connections; (c) the theft, destruction, loss or unauthorized access to, or alteration of, entries; (d) any problems with, or malfunctions or failures of, telephone networks or lines, computers or computer on-line systems, servers or providers, computer equipment, software, viruses or bugs; (e) garbled transmissions or miscommunications; (f) failure of any email, or social media direct message to be received by or from the Sponsor for any reason, including but not limited to traffic congestion on the Internet or at any website or combination thereof or technical incompatibility; (g) damage to a user's computer equipment (software or hardware)

occasioned by participation in this Contest or in connection with the Sponsor Website; or  
(h) any failure of the entry, draw or other Contest process.

## **PRIVACY POLICY.**

By participating in the Contest, each entrant agrees that the Sponsor has not made any warranty, representation or guarantee express or implied, in fact or in law, with respect to the prize and specifically disclaim all such warranties, including without limitation, the implied warranties of merchantability and fitness for a particular purpose. The invalidity or unenforceability of any provision of these Contest Rules shall not affect the validity or enforceability of any other provision. If any provision of the Contest Rules is determined to be invalid or otherwise unenforceable, then the Contest Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. Should a winner make any false statement(s) in any document referenced above, the winner may be required to promptly return to Sponsor his/her prize, or the cash value thereof.
20. In the event of any discrepancy or inconsistency between the provisions of the Contest Rules and disclosures or other statements contained in any Contest related materials, including but not limited to the Contest entry form, or radio, television, print, online

advertising, the provisions of the Contest Rules shall prevail and govern. The headings of the sections of the Contest Rules are for convenience of reference only and shall not affect the interpretation of the Contest Rules.

21. This Contest is governed by the law of Canada. Each entrant agrees, to the extent permitted by law, that any judicial proceedings relating to any disputes, claims or causes of action arising out of or in connection with the Contest shall take place in a provincial court within Ontario.
